# **Baseline Emissions Footprint**

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

#### **Baseline Year:**

Why the year was chosen

During 2020 patterns of business activity were severely erratic owing to pandemic-related office closures and other operational restrictions. 2021 has therefore been chosen as the baseline year even though some carbon reduction actions were already beginning to be implemented during Q4 2019.

#### What data is collected

GHG Emissions data is collated for Scope 1, Scope 2 and Scope 3, including all relevant categories. The data has been verified by an external provider (Interface NRM) demonstrating that the Emissions Footprint has been produced using GHG Protocol Guidelines and conforms to the requirements of the ISO 14064 standard.

### **Emissions Reduction Targets**

In order to continue our progress to achieving Net Zero, we have adopted the following near-term and long-term science-based carbon reduction targets:

## Near-Term

Near-term science-based targets cover an SME organisation's Scope 1 and 2 emissions reduction targets to be achieved by 2030. For LandScope Engineering, with base year (2021) scope 1 and 2 emissions of 84 tCO2e, a reduction of 42% minimum will be required by 2030. This means scope 1 & 2 emissions shall be no higher than 48 tCO2e by 2030.

#### Long-Term

Long-term science-based targets show how much an organisation needs to reduce its total emissions (Scope 1, 2 & 3) in order to reach net-zero. This is a minimum of a 90% reduction and needs to be achieved no later than 2050. LandScope Engineering's total emissions in its 2021 base year were 311 tCO2e. By 2045, its total emissions shall be no higher than 31 tCO2e, with the remaining emissions being permanently balanced through nature-based or technological solutions.





## **Carbon Reduction Projects**

#### **Completed Carbon Reduction Initiatives**

The following environmental management measures and projects have been completed or implemented since the Base Year:

- Installation of solar panels at Head Office
- Purchase of EV Toyota Proace van
- Installation of EV charging points at Northern and Southern office
- · Dedicated fleet management to reduce journeys

The carbon emissions reduction achieved by these schemes equate to

- Scope 1: -12 tCO2e, a 17% reduction against the Base Year
- Scope 2: -2 tCO2e, a 24% reduction against the Base Year
- Scope 3: +41 tCO2e, a 18% increase against the Base Year

Overall, GHG emissions have grown by 9% over this two-year period. We will continue to find ways to reduce our Scope 3 emissions, but they are partly an artefact of the growth of the company during this period: tCO2e per £100k of Turnover has reduced by 21%.

### **Future Carbon Reduction Initiatives**

We intend to invest in the following initiatives within the next 3 years:

- Scope 1: Procurement of a further EV van and dedicated use of the current EV van for mobile mapping activities, typically covering 10,000 miles per annum, equivalent to approx. 4tCO2 reduction.
- Scope 2: Switch energy supply to a 100 per cent renewable tariff
- Scope 3: Extended project to analyse emissions hotspots and alternative procurement/working strategies.

An ESG consultant has been retained to support the company with its carbon reduction initiatives
